INTERGENERATIONAL EXCHANGE WITH THE KOGI PEOPLE

(SCIENCE FESTIVAL CO-ORGANIZED WITH THE DOME)



On the occasion of the Science Festival organized by the Dome, the Normandy Chair for Peace organized an intergenerational meeting with the Kogi people. On October 5, 2021, from 3pm to 4:30 pm, the meeting took place in the Amphitheatre of the MRSH (University of Caen Normandy) and in distance. It was an opportunity to deepen collectively on the importance of our link with the Earth, making the public aware of the ancestral knowledge of indigenous peoples through the participation of two representatives of the Kogi indigenous people:

- **ARREGOCÉS CONCHACALA ZARABATA**, Governor of the Kogi Cabildo, traditional authority of the Kogi people, with extensive knowledge, experience and leadership in the exercise of ancestral public authority within the framework of the Kogi self-management structure, and intercultural relations in the ancestral territory of the Sierra Nevada de Santa Marta.

- **JORGE NUVITA CORONADO**, Health coordinator of the Gonawindúa Tayrona organization. Indigenous leader of the Kogi people, coordinator of various political processes, social and community organization of the Kogi people and inter-institutional relations on issues of territorial planning, education, intercultural health, human rights, food security, among others.

In addition, the dialogue also included interventions from two experts who have had the opportunity to visit the Kogi community in the Sierra Nevada de Santa Marta in Colombia and who dedicate their research and efforts to sharing the vision of this indigenous people and their struggles:

- **FALK PARRA D.** in Anthropology from Cambridge University in England and member of the British NGO Tairona Heritage Trust. He is currently developing dialogue and collaboration between indigenous ecology and conservation science around regeneration and environmental education, for example through BRIDGES, the UNESCO-MOST coalition for sustainable science.

- **ÉRIC JULIEN**, geographer (DEA) and graduate in Political Sciences. Founder of the NGO, Tchendukua - Here and Elsewhere, specialized in the accompaniment of «root» peoples and the preservation / reconstitution of Biodiversity.

WORLD YOUTH FOR CLIMATE JUSTICE TRAINING

BERLIN, OCTOBER 21ST-24TH, 2021



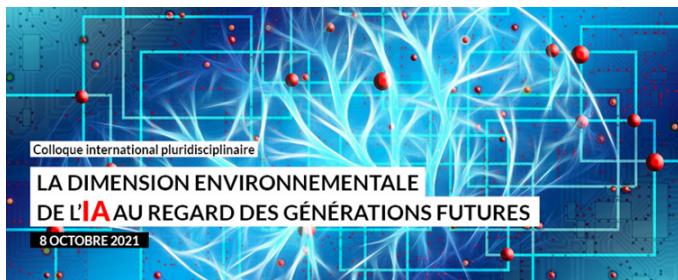
The organization World Youth for Climate Justice (WYCJ) has launched a global campaign to request an advisory opinion from the International Court of Justice on the legal consequences of climate change on human rights. To strengthen this campaign, four days of training and seminars were organized from 21st to 24th October in Berlin by the WYCJ and funded by the association Young Nature Friends Germany. This long weekend was organized for young Europeans motivated to carry this project in their respective countries.

Three students from the Transitions campus in Caen of Sciences Po Rennes went to Berlin because of their involvement in this project in collaboration with the Normandy Chair for Peace. There, they met with twenty or so young Europeans with whom they exchanged and shared tips and best practices. Most of the participants were already familiar with the world of international negotiations through their work as United Nations youth delegates. Four prestigious guests also joined the training to share their knowledge and experience, either remotely or face-to-face: **HERMANN OTT** (lawyer in international environmental law at ClientEarth), **Dr. FILIPPO FONTANELLI** (expert in international law), **ALYN WARE** (expert in nuclear policy, alternative Nobel Peace Prize winner), and **MARIA FERNANDA ESPINOSA** (President of the UN General Assembly in 2018 and former representative of Ecuador to the United Nations). The participants received their teachings and advice on climate justice and law, and were particularly trained on different lobbying practices, including lobbying towards states. Indeed, the campaign at the national level aims first of all to obtain the vote of a maximum of States at the United Nations since to ask for an advisory opinion to the international court of justice, it is first necessary to gather a simple majority of the 193 member States of the United Nations.

These four days of training were very rich in new encounters, information and opportunities: the students came back very motivated to continue this campaign in France by applying what they learned in Berlin, as well as to use the contacts they acquired during this stay.

INTERNATIONAL INTERDISCIPLINARY SYMPOSIUM BIOETHICS RESEARCH LINE

This Symposium about The environmental dimension of AI with regard to the rights of future generations, is part of the cycle of conferences entitled Thinking Transhumanism organized from 2018 to 2021 under the auspices of the French Commission for UNESCO. This cycle has allowed the organization of hearings, seminars and symposiums to understand the legal, ethical, sociological, but also economic and industrial dimensions of transhumanism and to confront this new trend of thought to the cultures of the world.

This international and multidisciplinary meeting was organized in Caen within the framework of the Normandy Chair for Peace and the Quality and Sustainable Environment Risk Pole of the MRSH (University of CAEN), under the scientific responsibility of **ÉMILIE GAILLARD**, **BÉNÉDICTE BEVIERE-BOYER**, **AMANDINE CAYOL** and **CHRISTIAN BYK**.

This symposium alternated round tables and high-level presentation sessions around the environmental dimension of artificial intelligence through the prism of the duties and responsibilities of today's humanity towards future generations. How to think about the ethics of AI within reasonable environmental limits? What are the environmental consequences of AI? What philosophy, what sociology, what hard sciences to help transhumanism articulated around AI apprehended through its negative environmental externalities, including in the medium and long term?

The participation of speakers from different regions of the world had as stake, through the diversity of cultures, a crossroads of multidisciplinary analysis on the future of the human being in the era of the globalization of AI and the deployment of transhumanism in the 21st century.

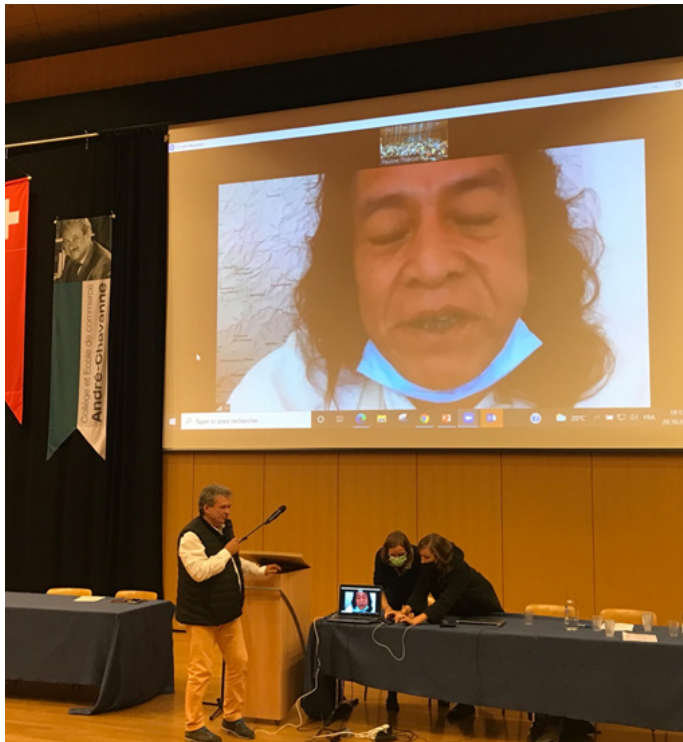

TERRITORIAL HEALTH GATHERING DIAGNOSIS OF THE GENEVA BASIN AND THE RHÔNE



On Thursday, October 21st and Friday, October 22nd, 2021, the Tchendukua Foundation held a territorial health diagnosis of the Lake Geneva and Rhone basin at the Brocher Foundation in Switzerland. The objective was to explore the proposal of a cross territorial health diagnosis inspired by the prototype carried out in the Diois in 2018.

In 2018, Geneva was chosen by the **Kogis** to host this diagnosis which is a world 1st. A meeting that will allow them to share their knowledge on living beings and territories with experts from various fields of modern and ancestral science in 2022.

These two days in 2021 of transdisciplinary and transcultural gathering, accessible by invitation only, aimed to bring together the members of the scientific committee, about forty Swiss and European scientists and a Kogi delegation gathered by the **Kogi** Governor by teleconference from Colombia.

Between music and reflection on the challenges of this experiment, the outlines of the first prototype conducted in the Drôme in 2018 and the perimeter of the **GENEVE 2022** diagnosis were shared and discussed by participants from all walks of life, in order to set out the next steps and the possible commitments of each and everyone.
