RIGHTS OF FUTURE GENERATIONS - PEACE - ENVIRONMENT

1-6 SEPTEMBER 2022 - CAEN (FRANCE)

The NCP Summer School will take place from **September 1st to 5th, 2022 at the University of Caen** (Normandy, France). It will be followed by 1 day of discovery of Normandy and its history on September 6th.

Students from various backgrounds and educational levels will gather in Normandy during this summer session to learn about key issues and initiatives undertaken by the Normandy Chair for Peace. The summer school is also open to university lecturers, researchers and professionals dealing with human rights and environmental law, alongside national and international officials, and NGO members.

This summer session provides an opportunity to deal with a wide range of themes concerning the historical need for a right of future generations. We will tackle an extensive array of subject matters

such as **climate change, transitional justice, the necessity of a dialogue with indigenous peoples, international environmental law, human security**, and other interconnected issues.

On September 5th, the NCP summer school will hold a Model United Nations simulation on climate, existential risks, peace and human security to explore how multilateral negotiations take place. Two training sessions in Zoom will take place in August with coaching provided by NCP members.

Based on the main principle that « **We will have peace on Earth, when we will have Peace with the Earth** », the NCP intends to widely share with Anglophone and Francophone participants expertise in the areas of future generations law, Sustainable Development Goal (SDGs) and sustainable peace.

PROVISIONAL PROGRAMME

Summer School : From September 1st to the 5th

- Welcoming dinner August 31st evening
- Day 1: **General backgrounds on the historical need to develop Rights of Future Generations**
The NCP summer school will start with the welcoming words of key international leaders and members of the NCP. The morning session will provide a link to the topics currently discussed within the UN institutions and the themes addressed during the Summer School. On this occasion, the Dean of the University for Peace (UPEACE, Costa Rica) will speak. The afternoon session will focus on the need to develop an ethical approach to transgenerational and decolonized thought. The entry into the age of Anthropocene presupposes responsible innovations.
- Day 2: **Rights of future generations: from declarations to processes of metamorphosis of Human Rights systems**
This training day will address the topic of The Rights of Future Generations and the shift from the principle of intergenerational equity to a transgenerational approach of human rights. We will explore the subject of Rights of Future generations more deeply, looking at its various expressions in domestic and international law, its implications for policy and initiatives to publicise and enact such rights. Key judicial actors will express their direct interest in this approach, in partnership with the NCP.
- Day 3: **Restoring justice by making Peace between the Earth and Humans: the need to establish a dialogue with indigenous communities**
Day 3 will engage an inaugural session on the benefits that indigenous peoples contribute to protecting the Earth and Human rights, in the context of long-overdue recognition of their right to self-determination under international law. Luminaries who witnessed the adoption of the General Assembly United Nations Declaration on the Rights of Indigenous Peoples will be present. A presentation on Kogis' knowledge and the

research project Āramāt will broaden the vision and conception of peace with the Earth. A specific session on transitional justice and indigenous people will then take place. Finally, a special focus on the Colombian case and the Special Court for Peace will close the day.

- Day 4: **From the universal scale to the Normandy Region: ensuring the promotion of Peace with the Earth**

Under the patronage of the Honorable Ambassador of Vanuatu (to be confirmed), we will review the issue of human security and peace in the age of climate change. Experts will also present International reports and comparative scientific studies on the opportunity to seize various international jurisdictions on the transgenerational issue of climate change. This session will also serve as an opportunity to present the international campaign "World's Youth for Climate Justice," supported by the NCP. From the global level to the territorial level, the day will end with the celebration of various institutions and initiatives led by the Normandy Region and the NCP. We are also considering an immersive experience in the Virtual Reality room designed to experience the consequences of climate change in Normandy.

Day 5: Model United Nations : Peace, climate, human security and rights of future generations
We will dedicate the last day of the summer school to simulating an UN institution plenary meeting on existential threats to Humankind and to the Earth. Two advance preparatory training sessions will take place *via Zoom* in August. This session of the summer school will conclude with a graduation ceremony by the end of the day. (End of the Summer School).

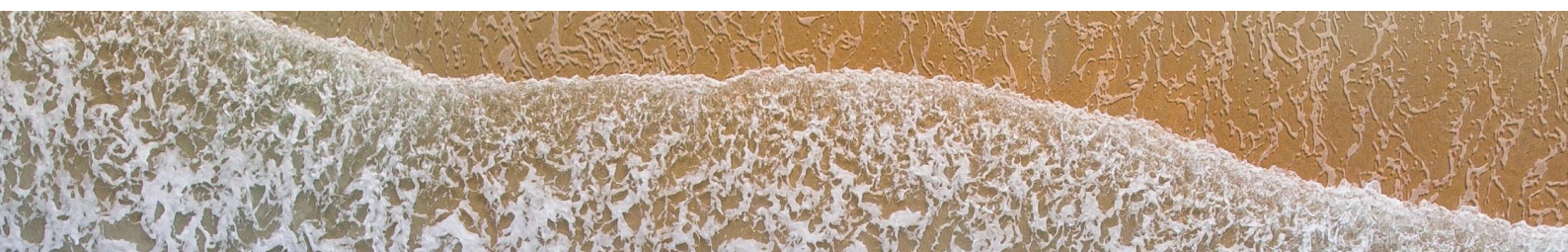
